WETWALL™ LIMITED COMMERCIAL 3-YEAR LIMITED WARRANTY COMMERCIAL PURCHASE FOR NON-RESIDENTIAL APPLICATION

WHAT IS COVERED:

Wilsonart LLC ("Wilsonart") warrants that during the warranty period specified below, the Wetwall™ Wall Panel System ("Wetwall"), will be free from defects in material and manufactured in accordance with appropriate specifications during commercial use and service for three years from the date of sale ("Warranty Period"). To activate this limited warranty, the original commercial purchaser must go online to www.wetwall.com/warrantyregistration to register Wetwall within thirty (30) days of purchase.

WHO MAY USE THIS LIMITED 3-YEAR WARRANTY:

Wilsonart extends this limited warranty only to the original, commercial (non-consumer) purchaser for non-residential applications who purchased Wetwall, or the business operating at the original location of the installation; there may not be duplicative recovery for the same issues. This warranty applies only to commercial purchases of Wetwall for non-residential applications. For residential application of Wetwall Panels, please see Wilsonart's limited 10-year residential limited Wetwall warranty.

WHAT DOES THIS LIMITED 3-YEAR WARRANTY COVER:

Wetwall will be free from defects in material and manufactured in accordance with appropriate specifications

WHAT IS EXCLUDED:

This warranty shall not apply to damage arising from any of the following:

1. Normal wear and tear;
2. Accidents, abuse or misuse;
3. Exposure to extreme temperature changes, use in the vicinity of high moisture (e.g., swimming pool or hot tub) or extreme heat (e.g., spa, sauna, steam room), outdoor use;
4. Exposure to harsh or corrosive chemicals and cleaners;
5. Excessive weight placed on or against wall panel;
6. Movement of the building due to land slip, failure of a foundation or the underlying building structure;
7. Improperly installed, used and/or maintained appliances, fixtures, or accessories;
8. Acts of nature;
9. Failure to use or maintain the product in accordance with Wetwall's published Care and Maintenance Guidelines (see www.wetwall.com or information supplied to Wetwall's distributors and retailers).

This limited warranty does not cover any labor or other costs of removal or installation or the cost of repair or replacement of any installation materials, including but not limited to tile(s), marble, etc. In no event shall the liability of Wilsonart exceed the purchase price of the Wetwall product. Damages due to improper handling, installation or maintenance are not considered manufacturing defects and are not covered by this warranty.

Neither transfer of commercial ownership nor repair or replacement under this warranty shall extend the Warranty Period. Any repair or replacement under the warranty is limited to repair or replacement with Wetwall colors and styles of products available at the time of repair or replacement. If the original color or style is no longer available, Wilsonart has the right to substitute another Wetwall color or style of equal or greater value than the original product. Exact color matches may not be possible

WHAT YOU NEED TO DO:

To make a claim under this warranty, you must contact the Wetwall Warranty Center at the address listed below before the end of the Warranty Period. You must provide dated proof of purchase and provide access for inspection for warranty determination. Wilsonart will investigate, and Wilsonart will provide you a determination on your claim.
